



Dear visitors,

Prior to signing the Statement ("**Statement**") given by users of *Zabavni park* (amusement park), you are kindly asked to carefully read the text of the Statement. Terms and definitions used in the text below have the following meaning in the Statement:

- A. "**Company**" – means the company SKAKAONICA DVA DOO d.o.o. Vojvode Milenka 8, Beograd – Savski Venac, reg. No. 21832618, TIN 113253421.
- B. "**Protocol**" means the protocol on safety requirements, which is Enclosure 1 and an integral part of the Statement.
- C. "**Zabavni park**" – (amusement park) means the amusement park area, including the Company playroom, being in SM2.16 room within "AVA Shopping Park" retail amusement park, Astrid Lidgren Str., cadastral plot 210/31 Voždovac cadastral area, owned by the Company, intended for entertainment and recreation (*as defined below*) of Users of appropriate age, as defined in the Protocol.
- D. "**Equipment**" - means a set of apparatuses and equipment within *Zabavni park* intended for fun and sports and recreational activities of the Users, and are the property of the Company or possessed by it.
- E. "**Service**" – means sports and recreational services and other related services provided by *Zabavni park* along with the use of Equipment, whereby the type, scope and duration of the provision of services and prices of services provided by *Zabavni park* are stated in the price list available at the reception desk of *Zabavni park* and posted on the official web page of the Company.
- F. "**User**" – means a physical person – visitor to *Zabavni park*, who signs the Statement and who, prior to using the *Service of Zabavni park*, either independently or through a parent or legal representative signs the Statement and becomes entitled to use the Equipment and Services in a manner and in accordance with the provisions of the Protocol.
- G. "**Safety requirements**"– means a set of rules and obligatory acts of Users visiting *Zabavni park* relating to the manner and conditions of use of the Equipment and Services provided by the Company within *Zabavni park* and defined in the Protocol.
- H. "**Personal data**" – means data on Users that include:

- (i) User's first name and surname, one parent's or User's legal representative first name and surname;
- (ii) User's telephone No. and e-mail address.

If the User is a minor, personal data on the User are given by a parent or legal representative of the User at signing the Statement.

Personal data such as telephone No. and e-mail address are non-obligatory data in accordance with the Law on Protection of Personal Data ("**Law**") and Notification on User's personal data collection ("**Notification**"), enclosed as Enclosure 2 being an integral part of this Statement.
